As a **Parent** of an official player for either the NCRL, NCSL, a FCBC Tournament Team or a High School team, I understand that I have a responsibility as a role model and that my actions are visible to players, parents, umpires and league officials, therefore, I agree to uphold the following standards:

1. I will treat each individual (player, opposing coach, official, parent, or administrator) with respect and dignity, and exhibit exemplary conduct at games and practices.
2. I will not engage in any negative emotional, psychological, or physical contact toward anyone involved with FCBC.
3. I will respect the judgment, strategy and decision-making process of the coaches, and will not publicly criticize coaches or players for any reason.
4. I will not confront a coach or player before, during, or immediately after a game, but will find an appropriate time to discuss any issues.
5. I will temper my reactions and investigate situations before taking action.
6. I will attempt to understand the National Federation of State High School Association baseball rules, including any and all Rule Modifications established for my team's age group.
7. I will show respect and support the authority of officials who are assigned to the game and will not hold them or unforeseen weather accountable for game results.
8. I will show compassion for any injured player and will applaud good play by either team.
9. I will not heckle, jeer, nor distract players of any team and will avoid the use of profanity or other inappropriate language or behavior.
10. I will not give false or misleading information of any kind to FCBC.
11. I will conduct myself in a positive manner while representing my player's team and the FCBC at any non-league team function or tournament.
